PUBLIC-PRIVATE PARTNERSHIP IN MUNICIPAL SOLID WASTE DISPOSAL SERVICES

INVITATION FOR EXPRESSION OF INTEREST

The City of Belgrade is restructuring solid waste disposal activities, through the first Public-Private Partnership (PPP) in the municipal solid waste sector in Serbia.

The PPP will consist of a long-term concession contract with a private partner, for the operation of the Vinča landfill. The project will include (i) the operation of the landfill in accordance with the provisions of the contract, Serbian and EU regulations and standards, (ii) the remediation of current disposal area, including realization of leachate treatment and gas collection systems, (iii) the construction of new landfill cells on adjacent land, and (iv) other activities, including the treatment and disposal of medical waste. The municipal company Gradska Cistoca is currently responsible for the collection and disposal of approximately 560.000 tons of municipal solid waste per year in Belgrade.

The City has hired the International Finance Corporation (IFC), a member of the World Bank Group, as its lead advisor for the structuring and implementation of the PPP.

Following the Concession Enactment of the Government of Republic of Serbia 05 No 35-3653/2006-5 from December 21 2006, published in Official Gazette of Republic of Serbia No 114/06, Expressions of Interest (EoI) are sought from companies, or consortia of companies, with experience in waste disposal and treatment. EOIs, in English or Serbian, including a short description of the activities (max. 3 pages) and copies of the two most recent detailed audited financial statements, should be sent to the IFC, with a copy of the cover letter to the City of Belgrade, at the addresses below, by February 16, 2007.
